CALL TO ORDER / AGENDA REVIEW

Mr. Connor declared that a quorum was present and called the meeting to order at 6:31 p.m.

ACTION AND DISCUSSION ITEMS

Eliot House Window Project

Mr. Greenberg presented a revised rendering of the Eliot House as it now appears and as it would appear with the proposed replacement windows, fulfilling the HOA requirements necessary to gain architectural approval. He also presented a paint sample of the window frame color chosen by Eliot House residents. Discussion ensued regarding the project where Mr. Greenberg stated they will replicate the first floor windows to what they are currently, all being either hopper or all single hung windows with a dark tint. Kim Ruhlander moved to approve the Eliot House Condominium Association's architectural approval of the revised window replacement project. 1) All window frames shall be painted "silversmith", a color manufactured by Valspar Corporation. Code 399C1158. 2) All insulated glass, with the possible exception of the first floor, shall be with a low e coating. 3) All balcony doors shall have their two adjacent windows combined onto one. 4) All operable windows, with the possible exception of the first floor, shall be of one type; single hung. 5) All fixed windows shall remain fixed and in their present locations. 6) The Eliot House Board shall retain the discretion to replace the first floor management office, HOA hospitality room, and laundry room windows with an operable type (hopper or single hung), tint, and uniform configuration that best addresses the safety and security concerns of the Eliot House. This shall be done in consultation with the window project architects and installers. David Beck seconded the motion and it was approved unanimously.
