Until then, you can use your receipt and a Photo ID to use the pool. No Refunds or Credits.

I hereby apply for Membership at the Sandburg Village Pool and Cabana Club. I understand that this application is subject to the review and approval of the pool management. Upon acceptance of this application the undersigned shall receive the membership rights and privileges, and agrees to abide by all rules and policies, which are subject to change without notice. I understand that this membership may be terminated by Fitness Formula or the Sandburg Village Homeowners' Association as a result of a violation of the rules, regulations and policies, conduct in a manner which management deems inappropriate or disruptive to others, false representation of information, or transfer of membership rights—which is strictly prohibited. I will not be entitled to any refund of the membership dues paid. I understand that the cost of seasonal membership is in addition to any apartment rental or Homeowners assessment and that membership dues are not refundable. I understand that the Sandburg pools may be closed as a result of needed repairs and maintenance and unfavorable weather conditions.
